





### **New Parks Ready to Open!**

You have seen the photos of the park groundbreakings. You have read the construction updates. You have seen the news stories about the new parks that are coming to Atlanta. This spring, the wait is over.

The first phase of Historic Fourth Ward Park is now open, and a dedication and grand opening for the entire park is scheduled for June 18. As part of the second phase of Historic Fourth Ward Park, the new skatepark is almost finished and ready for its grand opening. The skatepark was the recipient of a Tony Hawk Foundation grant, and will quickly become a destination for skateboarders all over the city and the region.

D.H. Stanton Park in the Peoplestown neighborhood will open in May. This park features photovoltaic solar panels, making it Atlanta's first energy cost-neutral park, which will provide tremendous cost savings to the City over the long term. It also features a little league-size ball field, a playground, splashpad and multi-use field. Boulevard Crossing Park Phase I, opening later this year, is located south of Grant Park. It will provide multi use ball fields to the neighboring communities.

### From the desk of the President and CEO:

This is our first newsletter in 2011, and there is already so much to talk about. All of the new Atlanta BeltLine parks and trails that broke ground in 2009 and 2010 are opening this year, and transit on the Atlanta BeltLine will be a major focus. We want you to be there to celebrate and work with us to keep moving the Atlanta BeltLine forward.

ABI is developing a Transit Implementation Strategy that will identify all of the segments required to complete the Atlanta BeltLine loop and complementary on-street connections. In 2012, voters in the Atlanta region will be given the opportunity to approve a one percent sales tax for transit and transportation projects, also known as the Transportation Investment Act (TIA). The Atlanta BeltLine is pursuing this, along with additional funding opportunities, to deliver Atlanta BeltLine transit and provide new levels of connectivity throughout the city.

As we develop the Transit Implementation Strategy and pursue funding opportunities, we will continue to work with the community and hold public meetings to help guide our decision making process. There will be several chances for public participation regarding transit over the next year, and we've already seen a high level of interest and engagement from the first seven meetings we've held in 2011 on the subject of transit.

We have also added a new way for members of the public to engage and share opinions. Working with Peak Democracy, we have started an online forum to get additional input from the public on different topics. Check our website, www.beltline.org, to see what forums are active and share your thoughts!

We look forward to seeing you at the meetings and milestones we will have over the next few months!

# **Atlanta BeltLine Transit Takes Shape**

Atlanta BeltLine, Inc. (ABI) is developing a Transit Implementation Strategy including onstreet segments connecting the Atlanta BeltLine corridor to activity centers in Downtown and Midtown. Over the next six to nine months, the Transit Implementation Strategy will identify all of the segments required to complete the Atlanta BeltLine loop and complementary on-street connections. It will also match these segments to funding opportunities and develop priorities for implementation.

In 2012, voters in the Atlanta region will be given the opportunity to approve a one percent sales tax for transit and transportation projects, also known as the Transportation Investment Act (TIA). The TIA is one potential source of funding for Atlanta BeltLine transit.

Throughout the month of March, ABI sought public input, holding Study Group meetings and a new online forum run by Peak Democracy. This feedback, along with the regional TIA project selection criteria and opportunities to partner with other transit projects will help determine

which segments will be recommended for potential TIA funds.

Following the submission of the TIA recommendation, ABI will continue seeking out public input as the Transit Implementation Strategy develops. Online discussions will continue and new public meetings will be scheduled to engage Atlanta communities in the future of Atlanta BeltLine transit. Through the Transit Implementation Strategy, different segments and funding mechanisms are being identified to create a seamless transit system that will connect Atlanta's diverse neighborhoods to local hotspots, MARTA and to each other.

# Trees Atlanta Celebrates Arbor Day Along the Atlanta BeltLine!

This Arbor Day, volunteers gathered on the west side of Atlanta, grabbing shovels, gloves and thousands of saplings to adorn the area with a variety of native trees as part of the Atlanta BeltLine Arboretum, an effort spearheaded by Trees Atlanta.

With support and sponsorship from WABE 90.1 FM, Trees Atlanta mobilized 137 community members to get involved and help plant more than 2,700 saplings along the corridor in what is known as the WABE Grove.

Unlike traditional arboretums that are often located in parks or gardens, the Atlanta BeltLine Arboretum will follow a linear path,

lining the 22-mile corridor with foliage that will one day help communities identify each distinctive neighborhood.

Ensuring that tree planting initiatives blend cohesively with the city's existing flora creates a beautiful attraction along the corridor while promoting clean air, increased shade and neighborhood identity.

The Atlanta BeltLine Arboretum will be implemented by Trees Atlanta throughout the next two decades, and there will be countless more opportunities to get involved in the development of this piece of the Atlanta BeltLine project.

### The Atlanta BeltLine Hosts its First Annual Organic Land Care Symposium

Atlanta BeltLine, Inc.'s senior landscape architect, Kevin Burke, orchestrated the organization's first-ever Organic Land Care Symposium which took place on March 24 at the Atlanta Botanical Garden. The event aimed to educate attendees about utilizing organic and sustainable approaches to the management of public and private open spaces.

More than 100 attendees participated in the panels with renowned local and national experts who led discussions on hot topics like cost-effective organic land care techniques, natural urban farms and low impact options for land care maintenance. With the success of the Symposium's initial year, ABI plans to provide future educational opportunities that encourage sustainable land care practices both on and off the Atlanta BeltLine.
