Its functions include specifically defining the BeltLine plan; leading efforts to secure federal, state and local funding; continuing the BeltLine community engagement process; and serving as the overall project management office to execute the BeltLine plan, including the coordination of planning and execution activities with other City of Atlanta departments and managing all vendors and suppliers. Atlanta BeltLine Inc. is also responsible for tracking and reporting progress on the BeltLine to the Atlanta City Council, Atlanta Public Schools and Fulton County, the three taxing authorities that authorized the BeltLine TAD legislation in 2005.







The BeltLine has the extraordinary potential to positively transform the City of Atlanta. The BeltLine will combine parks and greenspace, transit and trails, transportation and pedestrian access, affordable workforce housing and public art along 22 miles of historic rail segments that encircle the urban core.

The BeltLine is happening! With the groundbreaking for Historic Fourth Ward Park on October 15, the ribbon cutting on the West End Trail a few days later and the acquisition of the Northeast transit corridor in progress, tangible pieces of the core elements of the BeltLine, transit, trails and parks, are underway. We are also engaged in long term planning, involving the community in our numerous public meetings all over the BeltLine redevelopment area.

Significant progress is underway on the administrative side as well. The first round of Tax Allocation District (TAD) bonds is on the verge of going to market, generating up to \$120 million in revenue to continue projects and planning in progress. The BeltLine Affordable Housing Trust Fund has been approved by the Atlanta City Council and funds for down payment assistance and development should be available by the beginning of next year. And, the first round of the Environmental Impact Study conducted in conjunction with MARTA is progressing well.

Equally as important, we are working with our TAD Advisory Committee and implementation partners to specify an Equitable Development plan within the Five Year Work Plan. The plan represents the fulfillment of a commitment to the community to ensure that investment and development within the BeltLine Redevelopment Area occurs in a geographically balanced and equitable way. The plan is scheduled to be ratified in December.

And to help us spread all the news and manage our communications effectively, we welcome Ethan Davidson as our new Director of Communications.

Every day we see the progress and we gain and galvanize new partners. Yes indeed, the BeltLine is happening!

Vote Yes on Amendment #2 on the November Ballot

"Restore the Option for Atlanta Public Schools to Participate in the BeltLine TAD"

Atlantans have a huge opportunity to voice support of the BeltLine during the upcoming election. A referendum appearing on the November 4 ballot offers Georgia voters the opportunity to approve the amendment of the Constitution of the State of Georgia to authorize school boards of education to use tax funds for redevelopment purposes and programs such as the BeltLine.

The existing 6500-acre BeltLine Tax Allocation District (TAD) was created in 2005 after receiving overwhelming support from the community and votes of approval by the Atlanta City Council, the Fulton County Commission and

the Atlanta Public School Board with all three entities contributing tax funds. TAD financing is the primary local funding source for the BeltLine and is expected to generate approximately \$1.7 billion of the total project cost of \$2.8 billion over 25 years. TAD financing does not require a tax increase, rather it is a means of using future tax funds to pay for investment in the BeltLine now.

In February 2008, the Georgia Supreme Court ruled to eliminate the use of school tax funds in TADs. If Amendment #2 is approved, it will restore the opportunity for Atlanta Public Schools to participate in the BeltLine TAD.

According to a 2007 analysis of TADs in Georgia commissioned by the Livable Communities Coalition, the tax base inside a TAD grows an average of 300 percent faster than the tax base in nearby communities outside of the TAD, with school districts benefiting greatly. The purpose of the upcoming referendum is to restore the ability of local boards of education to opt into a TAD.

It's all about restoring local control to schools. Additionally, given the dire state of today's economy and capital markets, TADs will be even more of an asset in attracting investment and jobs to Georgia.

City Council Approves BeltLine Affordable Housing Trust Fund Plan in Unanimous Vote

Council approved the BeltLine Affordable Housing Trust Fund policies and budget to ensure affordable housing along the

By a vote of 13-0, the Atlanta City Housing Advisory Board (BAHAB) worked diligently with the community and partners for over a vear to develop the BeltLine Affordable Housing BeltLine. The BeltLine Affordable recommendations for Atlanta

BeltLine, Inc. (ABI) and the Atlanta Development Authority (ADA). BAHAB, as well as the ABI and ADA boards approved the plan before it was sent to City Council.

The Trust Fund policies provide guidelines for longterm planning of affordable housing along the BeltLine

- Provide balance between targeting lower-income households and relatively higher income households
- Facilitate housing near jobs for working families who are otherwise priced out of this close-in housing market
- Serve as a catalyzing agent for the revitalization of communities along the BeltLine redevelopment area that have experienced disinvestment and decay
 - Support the mitigation of involuntary economic displacement of existing residents

In approving the plan, the Council also approved the use of designated tax allocation bond proceeds to address affordable housing needs. The funds will be held in the BeltLine Affordable Housing Trust Fund and will be administered by ADA. Funds should be available to potential homeowners and developers in early 2009.

In the first five years it is anticipated that 18 million dollars will be made available for affordable housing. Over the 25 year life of the project, the amount dedicated to this purpose is estimated to total 120 million dollars resulting in a projected 5,600 affordable housing units, depending on the TAD referendum on the November

Atlanta BeltLine Inc. President and CEO Terri Montague thanked the City Council for their action and commended the BAHAB members for their commitment to the project by creating a plan that adds a crucial component to the BeltLine and the City of Atlanta.



The BeltLine Environmental Impact **Study Team Hosts First Sessions** for Public Input

ABI and MARTA recently hosted the first round of public meetings for the BeltLine Corridor Environmental Study. The study will evaluate how the transit and trails within the BeltLine railroad corridor may be constructed with the least possible environmental impact and address key planning decisions such as whether the transit will be a light rail or trolley and how the trail and transit facilities will share the, at times narrow, BeltLine corridor. The first round of meetings focused on getting public input on the goals and objectives for transit and trails, the need for these types of improvements and the transit and trail routes to be reviewed in the study. These

meetings are known in federal terms as Scoping meetings, since they allow the public and agencies to provide input on the scope of the study prior to the beginning of any detailed technical analyses. Two meetings were held in each of the four quadrants of the City between August 19 and August 21. Following the meetings, the study team attended additional community gatherings, such as neighborhood association and NPU meetings to continue soliciting input from the public.

To date, nearly 400 comments have been received. All responses will be incorporated into the final Environmental Impact Study document that will be presented to the federal government. ABI and MARTA are partnering to conduct the two vear study in compliance with the statutes of the National Environmental Policy Act (NEPA). If approved, the study preserves the options to secure both State and federal funding for the transit and trails planned along the corridor.
